Azalea Festival Concert Ticket Promotion

OFFICIAL RULES:

The comments on the promotional post will be exported at the end of the entry period. The actual drawing date is subject to change at the sole discretion of the Sponsor.

- 2. ELIGIBILITY: Drawing is open to all North Carolina residents who are at least eighteen (18) years old or older. Selected entrants for prizes must be able to prove residency, age and provide a mailing address. By submitting an entry, Entrant agrees to comply with <u>NCEL social media policy</u>. Entrants DO NOT have to be a Player's Club or Lucke-Rewards member to win. No purchase is necessary to enter or win. Entrants are subject to all Sponsor Rules and Regulations, the North Carolina State Lottery Act, the drawing procedures and Facebook rules and regulations. FACEBOOK: Users enter by commenting on the promotion post. The posts may instruct users to respond with a comment. A valid entry shall be defined as the first response made by a user during the specified time period on the official Facebook post. Responses made on other Facebook posts will not be eligible.
