

“\$5,000,000 Fortune” Calls Promotion

OFFICIAL RULES:

1. **ENTRY PERIOD:** The North Carolina Education Lottery (“Sponsor”) \$5,000,000 Fortune Calls Promotion (“Promotion”) begins on Tuesday, August 6, 2019 at 1:00 p.m. Eastern Time (“ET”) and will end on Wednesday, August 14, 2019 at 11:59 p.m. ET. The Promotion will include one (1) drawing on Facebook and one (1) drawing on Instagram to be held at the conclusion of each entry period for a total of four (4) winners who will each receive twenty (20) “\$5,000,000 Fortune” scratch-off tickets – Game Number 685 (“Prize”).

The comments on each of the promotional posts will be exported at the end of the entry period. The actual drawing date is subject to change at the sole discretion of the Sponsor.

2. **ELIGIBILITY:** Drawings are opened to all North Carolina residents who are at least eighteen (18) years old or older. Selected entrants for prizes must be able to prove residency, age and provide a mailing address. By submitting an entry, Entrant agrees to comply with the [NCEL social media policy](#). Entrants DO NOT have to be a Player’s Club or Lucke-Rewards member to win. No purchase is necessary to enter or win. Entrants are subject to all Sponsor Rules and Regulations, the North Carolina State Lottery Act, the drawing procedures and Facebook rules and regulations. This Promotion and/or any parts thereof, including the award of any prizes, is void where prohibited by law. Employees of Sponsor, Scientific Games Corporation, Pollard Banknote Limited/NeoPollard, GTECH Corporation and/or IGT, Mullen Lowe Group, Wunderman Thompson, Spurrier Group and MDI Entertainment, LLC are prohibited from participating in this Promotion.
3. **HOW TO ENTER:** There is a limit of one eligible comment entry per social persona for the specified entry period during the Promotion. All entries must be submitted within the Drawing Entry Period for the drawing.

Winners will be randomly selected from the following method of entry:

FACEBOOK: Users enter by commenting on the promotion post with a reply that includes a “fortune” message that was displayed in a video. A valid entry shall be defined as the first response made by a user during the specified promotion time period on the official Facebook post. Responses made on other Facebook posts will not be eligible.

INSTAGRAM: Users enter by commenting on the promotion post with a reply includes a “fortune” message that was displayed in a video. A valid entry shall be defined as the first response made by a user during the specified promotion time period on the official Instagram post. Responses made on other Instagram posts will not be eligible.

An eligible winning entry must be deemed responsive to the instructions as posted by the Sponsor via Facebook or Instagram as determined by the Sponsor and adhering to the NCEL social media policy.

Entries sent via any other method, including through any other website submission, social media, U.S. mail/courier, drop-off, etc. will be disqualified.

1. **WINNERS & PRIZE:** Odds of winning in this drawing depend on the number of entries received for that drawing. Entries will be collected via qualified comments on the Promotion’s Facebook or Instagram post at the end of each Entry Deadline period for each drawing. Prizes are not transferable, assignable or redeemable for cash unless otherwise specified or required by law. Sponsor may substitute a prize of equal or better quality.
