

Big Ticket Tee - Big Money Scratch-Off Ticket Giveaway

OFFICIAL RULES:

1. **ENTRY PERIOD:** The North Carolina Education Lottery (“Sponsor”) Big Ticket Tee - Big Money Scratch-Off Ticket Giveaway (“Promotion”) begins on Tuesday, December 19, 2017 at 12 p.m. Eastern Time (“ET”) and will end on Tuesday, January 2, 2018 at 12:00 p.m. ET. The Promotion will include one (1) drawing to be held at the conclusion of the entry period for forty-four (44) winners who will each receive one (1) prize package (“Prize”). Each prize will include one (1) Big Ticket Custom T-Shirt and one (1) Big Money Scratch-Off Ticket.

The drawing will be held within seventy-two (72) hours of the entry deadline:

The reactions and comments on the promotional post will be exported at the end of the entry period. The actual drawing date is subject to change at the sole discretion of the Sponsor.

2. **ELIGIBILITY:** Drawing is open to all North Carolina residents who are at least eighteen (18) years old or older. Selected entrants for prizes must be able to prove residency, age and provide a mailing address. By submitting an entry, Entrant agrees to comply with [NCEL social media policy](#). Entrants DO NOT have to be a Player’s Club or Lucke-Rewards member to win. No purchase is necessary to enter or win. Entrants are subject to all Sponsor Rules and Regulations, the North Carolina State Lottery Act, the drawing procedures and Facebook rules and regulations. This Promotion and/or any parts thereof, including the award of any prizes, is void where prohibited by law. Employees of Sponsor, Scientific Games Corporation, GTECH Corporation and/or IGT, Mullen Lowe Group, Linq3 and MDI Entertainment, LLC are prohibited from participating in this Promotion.
3. **HOW TO ENTER:** There is a limit of one eligible reaction entry and one eligible comment entry per social persona for the specified entry period during the Promotion. All votes/entries must be cast/submitted within the Drawing Entry Period for the drawing.

Winners will be randomly selected from the following method of entry:

FACEBOOK: Users enter by reacting to, and commenting on the promotion post. The posts may instruct users to respond with a reaction or comment. A valid entry shall be defined as any reaction and the first response made by a user

during the specified time period on the official Facebook post. Responses made on other Facebook posts will not be eligible.

An eligible winning entry must be deemed responsive to the instructions as posted by the Sponsor via Facebook by determination by the Sponsor.

Entries sent via any other method, including through any other website submission, social media, U.S. mail/courier, drop-off, etc. will be disqualified.

4. **WINNERS & PRIZE:** Odds of winning in any drawing depend on the number of entries received for the drawing. Entries will be collected via comments and reactions on the Promotion's Facebook post for a combined pool of entrants for the drawing. Forty-four (44) entrants will be randomly selected in the drawing to win a Prize Package. Total Estimated Retail Value ("ERV") of the Prize Package is \$34. Prizes are not transferable, assignable or redeemable for cash unless otherwise specified or required by law. Sponsor may substitute a prize of equal or better quality. After a drawing is conducted and verified, eligible winners will be announced in a Facebook post and notified by direct message via Facebook. If selected entrants do not respond to the notification directing them to contact the Sponsor within forty-eight (48) hours of notification, they will forfeit the prize. All drawing entries are subject to verification by the Sponsor or its designee and may be disqualified if eligibility requirements are not met. The Prize Package will be mailed by certified mail to the address of the winning entrant. The Prize Package will include instructions on the activation date of the Big Money Scratch-Off ticket included in the Prize Package. The included ticket will not be active until after this date. If an entrant responded to the Sponsor's notification within the specified deadline but fails to provide an address to receive the Prize Package and/or fails to provide proof of age and/or North Carolina residency within seven (7) days of the Sponsor's notification via Facebook, they may be disqualified and the prize will be awarded to an alternate. Only one prize may be won by a person during the Drawing. An entrant can only win one prize regardless of whether they have commented, reacted or taken both actions on the promotion post.
5. **LIMITATIONS OF LIABILITY:** The Sponsor is not responsible for vendor error, interruption, deletion, or delay in operations, technical interruptions, including network, telephone equipment, electronic, computer, hardware, or software malfunctions of any kind, or inaccurate transmission of or failure to receive entry. The Sponsor reserves the right to cancel or modify the Promotion if it becomes technically or otherwise corrupted. The Sponsor reserves the right to disqualify any individual found to be tampering or attempting to tamper with the operation of the Promotion; to be acting in violation of these Official Rules; to be acting with the

intent to disrupt the normal operation of this Promotion; or to be otherwise acting in an unsportsmanlike manner. The Promotion is not sponsored, endorsed, administered by, or associated with Facebook.

6. RELEASE: By submitting an entry, Entrant agrees that the Sponsor reserves the right to use entrant's name, email address, picture, likeness and any other publicly accessible personal or biographical information collected from entrant for publicity and/or administrative purposes.
