

Year Supply of Carolina Cash 5 Online Play Giveaway Promotion

OFFICIAL RULES:

1. **ENTRY PERIOD:** The North Carolina Education Lottery (“Sponsor”) Year Supply of Carolina Cash 5 Online Play Giveaway Promotion (“Promotion”) begins on Monday, November 19th at 1:00 p.m. Eastern Time (“ET”) and will end on Sunday, December 2th, 2018 at 11:59 p.m. ET. The Promotion will include one (1) drawing to be held at the conclusion of the entry period for five (5) winners to receive three hundred and sixty-five dollars (\$365) worth of Online Play credit for the purchase of one (1) Carolina Cash 5 Play per day for three hundred sixty-five days (“Prize”). The Sponsor will deposit the Prize to the winner’s Online Play account, subject to the winner’s complete registration through the Sponsor’s Player’s Club and Online Play System*.

The comments on the promotional post will be exported at the end of the entry period. The actual drawing date is subject to change at the sole discretion of the Sponsor.

2. **ELIGIBILITY:** Drawing is open to all North Carolina residents who are at least eighteen (18) years old or older. Selected entrants for prizes must be able to prove residency, age and provide a mailing address. By submitting an entry, Entrant agrees to comply with [NCEL social media policy](#). Entrants DO NOT have to be a Player’s Club or Lucke-Rewards member to win. However, in order to redeem the Prize, selected entrants must establish a valid Player’s Club and Online Play account. No purchase is necessary to enter or win. Entrants are subject to all Sponsor Rules and Regulations, the North Carolina State Lottery Act, the drawing procedures and Facebook rules and regulations. This Promotion and/or any parts thereof, including the award of any prizes, is void where prohibited by law. Employees of Sponsor, Scientific Games Corporation, Pollard Banknote Limited, GTECH Corporation and/or IGT, Mullen Lowe Group, Linq3 and MDI Entertainment, LLC are prohibited from participating in this Promotion.
3. **HOW TO ENTER:** There is a limit of one eligible comment entry per social persona for the specified entry period during the Promotion. All entries must be submitted within the Drawing Entry Period for the drawing.

Winners will be randomly selected from the following method of entry:

FACEBOOK: Users enter by commenting on the promotion post. The post may instruct users to respond with a comment. A valid entry shall be defined as the first response made by a user that contains another user's name using the Facebook "mention" function in the promotion post during the specified time period on the official Facebook post. Responses made on other Facebook posts will not be eligible.

An eligible winning entry must be deemed responsive to the instructions as posted by the Sponsor via Facebook as determined by the Sponsor and adhering to the NCEL social media policy.

Entries sent via any other method, including through any other website submission, social media, U.S. mail/courier, drop-off, etc. will be disqualified.

4. **WINNERS & PRIZE:** Odds of winning in any drawing depend on the number of entries received for the drawing. Entries will be collected via comments on the Promotion's Facebook post for a combined pool of entrants for the drawing. Five (5) entrants will be randomly selected in the drawing to win a Prize. Total Estimated Retail Value ("ERV") of the Prize is \$365. Prizes are not transferable, assignable or redeemable for cash unless otherwise specified or required by law. No part of the Online Play credit associated with the Prize is redeemable for cash/payment. The selected entrant must apply all Online Play credit to the purchase of the available Online Play draw game(s) or forfeit any remaining value of the credit. Sponsor may substitute a prize of equal or better quality. After a drawing is conducted and verified, eligible winners will be announced in a Facebook post and notified by direct comment and message via Facebook. If selected entrants do not respond to the notification directing them to contact the Sponsor within forty-eight (48) hours of notification, they will forfeit the prize. All drawing entries are subject to verification by the Sponsor or its designee and may be disqualified if eligibility requirements are not met. Once the selected entrant established their Player's Club and Online Play account as instructed by the Sponsor, the Prize will be deposited into the selected entrant's established Online Play account. If an entrant responded to the Sponsor's notification within the specified deadline but fails to provide their full name, address, birthdate, phone number and email address and fails to establish a valid Player's Club and Online Play account within seven (7) days of the Sponsor's notification via Facebook, they may be disqualified and the prize will be awarded to an alternate. The Sponsor reserves the right to disqualify any individual found to be tampering or attempting to tamper with the operation of the Promotion; to be acting in violation of these Official Rules; to be acting with the intent to disrupt the normal operation of this Promotion; or to be otherwise acting in an unsportsmanlike manner. The Promotion is not sponsored, endorsed, administered by, or associated with Facebook.
